#### 4. REFUND POLICY/STUDENT'S RIGHT TO CANCEL

Refund is in accordance with Florida Department of Education Rule 6E-1.0032(6), F.A.C.

A notice of cancellation shall be in writing, and a withdrawal may be effectuated by the student's written notice or by the student's conduct, including, but not necessarily limited to, a student's lack of attendance. You have the right to cancel the enrollment agreement and obtain a refund of charges paid through attendance at the first class session, or the seventh day after enrollment, whichever is later. Any student who drops or cancels registration prior to the program beginning will be refunded any tuition paid, less a nonrefundable application fee. If you drop or cancel the program prior to the program start date, please contact the Wind Academy by Siemens Gamesa Admissions Department. If on or after your program start date, you must contact the Admissions Manager to drop or cancel. Any student dropping the program after it begins will be refunded a pro-rata amount, through the first 50% of the program. Any student dropping after 50% of the program has been completed will not be refunded any portion of the program tuition. All refunds due will be paid within thirty days of the drop date or cancellation. Each student who drops will be given a comparison of drop calculations from ALL regulatory bodies that Wind Academy by Siemens Gamesa is approved through.
